

## Terms & Conditions

### **“Most Attractive Employers in Sport 2022” Sweepstake Rules and Regulations (the Sweepstake)**

NO PURCHASE NECESSARY. SEE BELOW FOR FULL SWEEPSTAKE DETAILS. PARTICIPATION IN THIS SWEEPSTAKE CONSTITUTES YOUR FULL AND UNCONDITIONAL ACCEPTANCE OF, AND AGREEMENT TO BE LEGALLY BOUND BY, THESE SWEEPSTAKE RULES (the Sweepstake Rules)

#### SWEEPSTAKE PERIOD

1) Entries will be accepted online starting on or about December 21st 2021 and ending on February 28th 2022 at 11:59PM CET (the “Sweepstake Period”).

#### SPONSOR

#### ELIGIBILITY

3) The Sweepstake is open only to those who complete the “Most Attractive Employers in Sport 2022 Survey” and enter their name and surname at the end of the form and who are 18 years old or older as of the date of entry. The sweepstake is open to legal residents of all countries except those where prohibited by law. Employees of Engage Sport & Entertainment (the “Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstake. #### DRAW AND WINNER SELECTION

Drawings will be conducted by Sponsor, on March 1<sup>st</sup>, 2022. By entering the Sweepstake, entrants fully and unconditionally agree to be bound by these rules and the decisions of the Sponsor, which will be final and binding in all matters relating to the Sweepstake.

#### PRIZES

6) (i) One (1) FREE delegate pass to the iWorkinSport Job Fair, scheduled to take place on May 20<sup>th</sup> 2022, in Lausanne, Switzerland.
